Renter agrees to hold AVrent, it's owners, representatives, and associated entities free and harmless of and from any and all claims and demands that may arise through the use of, handling of, or malfunction of rented equipment. Renter shall return the rented equipment complete and in good condition. AVrent and any party it hires to remove the property from the premises should renter fail to return the equipment, can use any legal means to acquire the equipment and cannot be held responsible for any damages. Renter shall be responsible for attorney fees, court costs and collection cost. Rental cost plus the market value for the non **returned/stolen/lost** property shall be charged to the renter. This agreement does not imply sale of the equipment. Security deposit, if any, will be held for at least 24 hours after return of the property.

**Rental fee is non refundable.** Renter will be responsible for replacing consumable parts like lamps etc. **Technical support & Services:** Because of varied nature of use, AVrent does not guarantee fixing the problems but it will extend its services to help for a nominal charge of \$ .00 /hour .

**Right to refuse:** AVrent reserves the right to refuse rental to any individual or organization.

**Extension:** Renter will notify AVrent of any extension in the rental term. Renter will be charged for extended time, if renter fails to return the equipment on time.

**Cancellation / Changes:** Cancellation or change in date for the use of equipment must be made at least two weeks prior to the requested date for equipment rental. The renter will pay 25% of the rent for such cancellation. For any cancellation within two weeks, renter will pay 50 % of the full rent for the equipment. Any cancellation within one week ( 7 days), renter will be pay full rental fee. **Warning:** Failure to promptly return the rented property may result in criminal prosecution (RCW 9A.56.096) . **Authorization:** I authorize AVrent to charge the credit card listed above or provided over the phone or any other way.
